

# PROGRAMS OF COUNCIL

## **Cross Systems Training:**

Council's Public Information Committee is proud to offer trainings on multiple topics throughout the year. Education credits are often available.

## **Early Intervention:**

Early Intervention is a program of Council that is operated by the Ashtabula County Board of Developmental Disabilities. This program is available for children under the age of three who have demonstrated developmental delays. Call the Early Intervention office at (440) 992-2111 for more information.

# PROGRAMS OF COUNCIL cont

#### **Service Coordination:**

Service Coordination is a family driven process based on the strengths and needs of each individual and family that aims to eliminate redundancies and coordinate existing government services through the construction of a family team of both natural and professional supports.

The objective of Service Coordination is to be a preventative measure against out of home placements for youth.

Eligibility: Service Coordination is available to children and youths that meet <u>all</u> of the following criteria:

- Younger than 22 years of age (or 24 for the DD population)
- · Residing in Ashtabula County
- Has complex and/or severe unmet needs in two or more service systems (such as Children Services Board, Juvenile Court, Mental Health, Developmental Disabilities, etc.)
- At risk of out of home placement

#### Service Coordination is:

- Available to eligible families residing in Ashtabula County regardless of their income.
- A 100% voluntary program.
- Does not override systems with which the child/youth is involved
- Utilizes an innovative, changing the perception of the problem approach when traditional services fail to meet the child/ youth's needs
